


Del Oro Water Company continuously addresses system-wide improvements, many of which are a result of aging infrastructure. Below is a summary of emergency projects that are scheduled to be undertaken in the 2015/2016 fiscal period. Included is our best estimate of the cost to complete these tasks, the total potential impact on rates, and a description of the facilities and/or streets which will be addressed by this Capital Improvement Project.

In summary, Del Oro Water Company will immediately undertake:

Replacement of approximately 7,745 lineal feet of pipe with C900 Class 200 Poly Vinyl Chloride (PVC) transmission main on South Park, West Park, Glendale, Calvin, and Shaw, as well as 11 hydrants and 140 services at an estimated cost of \$1,000,000. Failure to complete this replacement will result in additional outages from mainline breaks, which increases the potential for flooding and property damage.

The rate impact is approximately \$3.11 per month for the average customer.
