Advice Letter No. 270-A

TO THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

Del Oro Water Company, Inc. (DOWC) hereby transmits this Advice Letter No. 270-A for filing on behalf of its Arbuckle (DOWCAR), Ferndale (DOWCFD), Magalia (DOWCMD), Pine Flat (DOWCPF), Pine Mountain (DOWCPM), River Island (DOWCRI), and Walnut Ranch (DOWCWR) Districts. DOWC has been tracking the revenue from the surcharge in the Water Quality Balancing Account as required by Penal Code 792.5. This Supplemental Advice Letter includes the required tariff sheet numbering following California Public Utilities Commission Staff approval. 

ANNUAL GENERAL METERED SERVICE

MAGALIA DISTRICT

- 8. Per Advice Letter No. 230, dated July 1, 2009, granting an Interim Rate Increase and Resolution No. W-4797, dated October 29, 2009, as corrected by Resolution No. W-4807, dated November 4, 2009, granting a General rate Increase, under-collected revenues amounting to \$6,755.36 from July 1, 2009 through November 10, 2009 are imposed in a surcharge of \$24.74 per customer over approximately six (6) billing cycles at \$4.12 per month to each customer's bill upon approval by the California Public Utilities Commission. If over-collection of funds occurs, a credit will be issued to the customers.

- 9. As authorized by the California Public Utilities Commission all bills are subject to a one-time Surcharge of \$6.04 billed over approximately three (3) billing cycles at \$2.01 per month to each customer's bill upon approval by the California Public Utilities Commission of Advice Letter No. 268. This charge offsets the California Department of Public Health fees as billed to the Magalia District for Fiscal Year July 1, 2009 through June 30, 2010.

- 10. As authorized by the California Public Utilities Commission all bills are subject to a one-time Surcharge of \$1.73 billed at \$1.73 over approximately one (1) billing cycle upon approval of Advice Letter No. 270. This charge offsets the expenses resulting from the Environmental Protection Agency's adopted National Primary Drinking Water Regulations for water testing for the period January 1, 2009 through December 31, 2009.
